The meeting was called to order at 6:02 PM.

Old Business

- Hardaway reported that the two PE1 action documents, Evidence of Participation in TCCOG and CLWIO organizations, were presented to and passed by the Board of Trustees. Hardaway submitted the two documents to the online CSC tracking system.
- For PE2 actions, Terry Carroll and Brian Toy are assisting with the development of the Village's Greenhouse Gas Inventory. DPW fuel charges, provided by Jodi Dake, were forward to Terry and Brian for inclusion in the GHG inventory document. Hardaway has received electronic histories of the Village's energy usage/charges for the past six years. He still needs to pull physical records from the Village's archive for the years 2013 and 2014, which reflect the Village's transition from the old office building to the new building.

New Business

The Task Force continued its discussion on the CSC Pledge Element action steps.

PE 8. Support a green innovation economy.

- PE8 Action: Green Jobs Training
 - Participant-only scope with TCCOG and TCAD.
- PE8 Action: Green Vendor Fairs
 - Could focus on all aspects of green economy, including: Engineering, Architecture, Farming, Electric lawnmowers, etc.
- PE8 Action: Green Economic Development Plans
 - o Participant-only scope.
- PE8 Action: Farmers' Markets

- Support local markets, including: Village Farmer's Market at Triphammer Marketplace, Ithaca Coffee Company - CSA pickup location, Triphammer Reuse - might also be a CSA pickup location.
- PE8 Action: Buy Local/Buy Green Campaign
 - Promote Village residents to support: U-Pick locations, Get Your Green Back, etc. CCE has good resources on vendors.
 - Plan and implement sharing knowledge with VOL residents.
 - o Include information in the VOL newsletters.
- PE8 Action: Brownfield Clean-up & Redevelopment
 - Brownfields sites Cornell (older site contaminated with radioactive and chemical elements) north of airport.
 - Borg-Warner site (future?)
 - TC International Airport?
 - Turn brownfields into small-scale solar arrays?
 - Document appropriate methods for identifying, monitoring and implementing clean-up plans.
 - Add guidance in Village Comprehensive Plan and Greenway Plan.
- PE8 Action: Incentives for Green Businesses
 - Participant scope for county level.
 - Future green businesses provide assistance via the Village.
 - o PILOT payments, etc.
- PE8 Action: Energy Benchmarking for Private Buildings
 - Out of scope county or utility level effort.
- PE8 Action: Financing Program for Building Energy Efficiency
 - o Probably out of scope state or county government-level effort.
 - Village might consider green revolving-fund loan for local businesses
 - Caroline and Binghamton have created these.
- PE8 Action: Community Choice Aggregation
 - Hardaway participates in the Energy subcommittee of TCCOG, which is focusing on CCA currently.
 - CSC Task Force members may join upcoming CCA webinars if they choose.
- PE8 Action: Solarize, Clean Heating & Cooling, or Solar for All Campaign
 - HeatSmart participation would count.
 - VOL hosted one info meeting last year with conversion vendors.
 - Solar Tompkins participation was not enough because there were too few conversions to solar to get credit.
 - VOL could promote a program to incentivize solar installations along with planning and code enforcement.

 - CSC and Village will need to continually review and update strategies and plans.
 - Revise Comprehensive Plan, Greenway Plan, and Village Code as needed.
