1 Village of Lansing 2 Planning Board Meeting 3 February 13, 2017 4 5 The meeting of the Village of Lansing Planning Board was called to order at 7:02PM by Chairman Mario 6 Tomei. 7 8 Present at the meeting were Planning Board Members: Mike Baker, John Gillott; Alternate Member, 9 Carolyn Greenwald; Code Enforcement Officer, Marty Moseley; Village Trustee Liaison, John O'Neill; 10 Village Attorney, David Dubow. 11 12 Absent: Deborah Dawson and Lisa Schleelein. 13 14 Tomei appointed Carolyn Greenwald as an acting member for the meeting due to the absence of Planning 15 Board member Schleelein. 16 17 **Public Comment Period** Tomei opened the public comment period. With no one wishing to speak, Baker moved to close the 18 public comment period. Seconded by Gillott; Ayes by Tomei, Baker, and Greenwald. 19 20 21 Al-Huda Islamic Center Update 22 Tomei reported that Al-Huda has submitted a new plan for their proposed building with the majority of 23 the parking now in the rear of the property, four handicapped slots being the only parking in the front, and 24 the building itself moved closer to Graham Road. They have asked whether it responds to the revisions 25 made by the Board at the previous meeting. 26 27 The Board indicated the plan looks acceptable. Moseley said he will communicate the Board comments to 28 Al-Huda. 29 30 **Trustee Report:** 31 Baker reported on the Trustee meeting of February 6, 2017. For a complete report of the meeting please see the Trustee minutes. 32 33 34 **Informal Presentation for Warren Road Medical Building (Parcel #4601-6-6.23)** located next to 100 35 Uptown Road 36 37 The applicant for the proposed Warren Road Medical Building was unable to make the scheduled 38 meeting. The Board felt it would be useful to look over the package of materials submitted for possible 39 consideration at a future meeting. 40 41 Gillott questioned whether the curb cut onto Warren Road would be acceptable and approved by the 42 County. Moseley indicated the County is not involved; Warren Road is a Village road. The DOT and 43 Board of Trustees have given positive feedback on the proposal and the driveway location. 44 45 Tomei noted the lack of wetlands on the parcel. Gillott felt the building is somewhat out of character with 46 the other nearby medical buildings, however, not all Board members agreed. 47 48 There was discussion about availability of natural gas at the site and the Board suggested the applicant be encouraged to approach NYSEG on this matter. Discussion and questions then moved on to buffer 49 50 requirements, tree removal and replacement, the extensive landscaping plan, a lighting plan requirement, 51 sidewalk requirements to Warren Road, need for a storm water management plan, and cross walk
