### COMMENTS FROM THE MAYOR

Welcome to the Fall 2025 Village of Lansing newsletter! As leaves begin to turn and we settle into (hopefully) cooler days, the village continues moving forward with exciting developments and progress. In this newsletter, you will read about the completion of our five-year Climate Smart Communities Bronze certification, ongoing DPW infrastructure enhancements, potential business and residential developments and openings, our successful domain migration to **[villageoflansingny.gov](http://villageoflansingny.gov)**, in-progress updates to our Village Code and Comprehensive Plan, new Village Board members, the completion and release of the Tompkins County Joint Safety Action Plan, and local community activities and service opportunities. Unfortunately, at both the federal and New York State levels, uncertainty and turbulence continue to shape our political and policy landscapes. In Washington, partisan divisions and recurring fiscal standoffs fuel instability, while in Albany, shifting priorities, budgetary pressures, and frequent political disputes create their own challenges. This combination of federal- and state-level volatility adds complexity to local governance and planning, making it difficult for communities to anticipate long-term impacts with confidence. However, be assured that our Village government and staff will continue to plan for the short- and long-term progress and stability within our community through our long-standing commitment to apolitical discussions, decisions, and actions.

With that assurance, I want to introduce our new Board members. In April's Village election, Patrick Gillespie, a long-time member of our Planning Board, was elected to his first term as a Village Trustee. Kevin Kelvington was appointed to the Planning Board replacing Yamila Fournier who stepped down to move to Ireland with her family for a couple of years. The Village Board of Zoning Appeals also has two new members: Devin Walker and Michael Wallisch. Please welcome these individuals to our local government.

## **Village Migrates to [villageoflansingny.gov](https://villageoflansingny.gov) Domain**

New York State will soon require that websites and emails for local governments with populations greater than 1,500 residents move to the .gov domain to clearly define a local government. To prepare for this state requirement, the Village of Lansing applied for and was approved to move to a .gov domain. Over the weekend of September 12-14, the Village successfully migrated from the old [vlsing.org](https://vlsing.org) domain to our new **[villageoflansingny.gov](https://villageoflansingny.gov)**, including the website (now <https://villageoflansingny.gov/>) and email accounts.

## **Donald Hartill, Longtime Mayor, Passes Away – Village Renames Park in His Honor**

We are profoundly sad to announce that longtime Village of Lansing Mayor, Donald L. Hartill, passed away on April 16, 2025. He was a trustee from 1989-1993 and deputy mayor from 1993-1996 before becoming the village's fifth and longest serving mayor, a position he held from 1996-2021.

To recognize Mayor Hartill's service to our Village, the Board of Trustees voted to rename the Marian Hartill Village Park to Donald and Marian Hartill Park. A new sign was ordered and installed in July.

## **VILLAGE CLERK'S OFFICE**

### **Sewer Rate Increases as of October 2025 Billing for Village Residents**

The Village of Cayuga Heights has increased its sewer rate from \$7.59 to \$9.48 per 1,000 gallons of water consumption. The Village of Lansing surcharge remains the same at 25% of the Bolton Point water rate or \$1.68. This results in a minimum sewer charge of \$55.80 or \$11.16 per thousand gallons of water consumption. This new rate will begin with your October 2025 billing. The Village of Lansing does not have its own sewer plant; it is sent to the Village of Cayuga Heights Plant.

### **Water/Sewer Bills**

Village of Lansing Residents receive a bill quarterly at the beginning of January, April, July, and **October**. You will receive a postcard bill if you have not signed up for eBilling only. All water/sewer bills are due by the 20<sup>th</sup> of that month and can be either mailed in or you may bring your payment to the Village Office at 2405 N. Triphammer Road. There is a secure drop box inside the entry way to our administration building for you to drop off your payment anytime. The Village does not accept credit card payments.

### **Village Sponsored Street Tree Planting Program**

### **NYCOM's 70<sup>th</sup> Annual Fall Training School for City and Village Officials**

The week of September 15, Clerk/Treasurer Jodi Dake and Trustees Carolyn Greenwald and Pat Gillespie attended the New York Conference of Mayors (NYCOM) Conference in Lake Placid. The weather was fantastic and the conference, as usual, was extremely informative. With the laws and requirements constantly changing, this is a great place to get up to date information from the Office of the State Comptroller and NYCOM.

Greenwald attended seminars on Local Government, Albany Update, Open Meetings Law, Customer Service, The First Amendment, Adopting Local Laws, Fund Balance Policy, Clerk Responsibilities, and Ethics. She came back with myriad ideas for the Village including updating or adding local policies, addressing more vigorously the state of vacant buildings along Triphammer Road, and other ways to best serve the Village.

As a newly elected Trustee, this was Gillespie's first NYCOM Conference. He attended seminars on Local Government, The State of AI in 2025, Responding to FOIL Requests, Municipal Websites and Cybersecurity, Customer Service in Local Government, Preparing for Protests and First Amendment Audits, Streets and Sidewalks, Understanding New York's New Requirements on Cybersecurity, and Social Media. The conference was very informative with a lot of information packed into the four days.

## **VILLAGE HIGHWAY DEPARTMENT**

### **Fall Brush Pick-Up**

The Town of Lansing Highway Department will begin the fall brush and limb collection service on **Monday, October 6**. Residents are asked to leave up to one pick-up truck size load near the roadside by 7:00 a.m. To assist the work crews, all limbs and brush (up to 5 inches in diameter) should be piled with the cut ends facing the same direction. The limbs should be no longer than 6 feet in length. Also, the piles should not be tied but should be left loose. Please do not put out bags of yard waste. This pick up is only for limbs and brush.

The Village of Lansing Department of Public Works will be finishing up the trail work in the Lansing Trails I area. We are scheduled to add the top course next week. Please avoid these areas if possible.

We are scheduled to have the portion of Graham Road from North Triphammer Road to Wakefield Road paved the week of October 13, weather pending. A profile milling machine will be used prior to paving the road.

The sidewalk improvement project for Uptown Road and Craft Road will see a temporary pause while the Village waits for the results of a grant application through Climate Smart Communities and NYSDEC. The results should be in later this year or early 2026. While waiting the village will fine tune the design and relocate any conflicting utilities.

Cayuga Hills and Hampton Hills were scheduled to be resurfaced this year, but, while performing routine cross culvert inspections, it was noticed that a few storm pipes will need to be replaced. We hope to replace

those this year and allow a freeze/thaw cycle. We will postpone the new surface until spring of 2026.

### **Sewer Expansion Update**

The Village officially sent out letters to residents along the new sewer benefit area on Cayuga Heights Road, Twin Glens Road, and East Shore Drive. ## **CODE & ZONING DEPARTMENT**

With fall upon us, I would remind everyone that there are numerous scenarios in which a building permit would be needed. I would encourage individuals who are interested in additions, new construction, remodeling, installation of a solid fuel burning heating appliance, chimney or flue, installation of new heating equipment, decks, solar arrays, pools, roofs, etc. to visit the Village of Lansing Office at 2405 North Triphammer Road or email me at [codeofficer2@villageoflansingny.gov](mailto:codeofficer2@villageoflansingny.gov) for any questions they might have. I will also be sending out letters to those who have open permits that may need renewal or a scheduled appointment to finalize. Please remember, an open permit may affect your insurance or ability to sell your home.

### **2024 NYS Uniform Code**

The new 2024 New York State Uniform Code will be in effect starting January 1, 2026. Some of the notable changes include:

- All new residential and commercial buildings must be all electric. (there are some exceptions)
- Sprinkler systems are required in the new construction of townhouses.
- There is an increase in Energy Code requirements.

### **Stormwater**

As beautiful as the fall leaves are, that means a lot of yard work for local homeowners. One option for reducing your workload is to use a mulching lawn mower to mulch leaves into your yard. It is less time intensive than raking and the shredded leaves act as a natural fertilizer during the fall. While you are tending to your yard, take a moment to sweep or rake leaves and branches out of the street in front of your house. Left in the street, they can clog storm drains and contribute to localized flooding. When washed into our nearby lake and streams via storm drains or ditches, the leaves become a major source of phosphorus, the nutrient that allows algae to bloom in the summer. Dispose of leaves by composting them in your yard is also a good alternative. Keep leaves and yard waste out of the regular garbage and never dump them in wetlands or buffer areas. Roofs, driveways, snow melt, and lawns all provide stormwater runoff that could potentially end up in Cayuga Lake. All should be mindful of what is spilled or placed on these surfaces. Please clean up any spills that occur, attempt to minimize the fertilizers for lawn care, and properly dispose of pet waste. This is an important task since the Village and four other municipalities are provided drinking water from Cayuga Lake.

**Please remember to check/replace the batteries in all Carbon Monoxide and Smoke Detectors.**

## PLANNING BOARD NEWS

In July, the Board of Trustees and the Planning Board held a joint meeting to discuss the goals of the upcoming Comprehensive Plan. We also had quite a few changes to the makeup of the Planning Board. Pat Gillespie left after being elected to the Board of Trustees, Yamila Fournier left because she was moving out of the area, and Kevin Kelvington was appointed as a new member. The Planning Board also met with multiple village residents who are interested in joining the Planning Board.

After much discussion, the Planning Board formally recommended changes for the Board of Trustees to review pertaining to the Tree Conservation and Planting Law. A special permit was granted to open a daycare and after-school program in a portion of the building location at 2343 North Triphammer Road, which is owned by Lama Brothers LLC. A subdivision was approved for 56 Burdick Hill Road, which also requires approval from the Town of Lansing due to its location. An informal presentation was given to the Planning Board regarding possible development of the property located at 11 Graham Road West.

For the last few months, the Planning Board has been focused on village code changes and corrections. This process involves reviewing the current chart of uses, associated code, terms/ definitions, and zoning of parcels. We are about 2/3 of the way through the review process and once that is completed we will go through all the recommended changes as a whole before recommending them to the Board of Trustees. We hope to have this process complete by the end of the calendar year.

### Update from Trustee Susan Ainslie

Donald Hartill, former Village of Lansing mayor, was the Village of Lansing representative on the Southern Cayuga Lake Intermunicipal Water Commission for many years before his passing. At the organizational meeting in May, Susan Ainslie was appointed to represent the Village along with Mayor Hardaway. Ainslie is on the Budget and Finance, Engineering and Operations, and Planning and Public Affairs committees.

Additionally, Ainslie serves as the Trustee liaison to the Greater Tompkins Insurance Consortium and as the alternate representative to the Tompkins County Council of Governments. Ainslie also continues to represent the Village on the Youth Services Board.

### Comprehensive Plan

As your Comprehensive Plan Committee Chair, Carolyn Greenwald is happy to report that the committee's draft of the plan is complete and is in the competent hands of Trustee Pat Gillespie for final design and formatting. The draft will be made available to the public shortly for viewing and comment. The Village will also hold a public hearing at the end of the year for additional public outreach and comments. ### **Town Trail Committee**

The Town of Lansing recently updated its Town Center Trail Policy to include all the current trails on one map and in one resolution. The Town Center trails are located at 90 Auburn Road, across from the Town ball fields and next to Salt Point Brewery. If you have never walked the trails, I highly recommend a visit. The fall colors and the vista are spectacular.

Using grant money, the Town has hired MJ Engineering to conduct a Lansing Town Center Feasibility Study and draft a Lansing Greenway Master Plan. In accordance with this, MJ is conducting a Town of Lansing Townwide Trail System Community Survey. The survey should be available in the next few weeks. Look for a link to the survey on the Village website.

### **Greenway Committee Update**

The new Comprehensive Plan calls for a Village Trails Network Master Plan and a Village Parks Master Plan. Creating these documents will take a lot of work but the committee is looking forward to advancing our parks and trails via a coherent and well thought out plan.

### **Village of Lansing Contributes to Countywide Safety Action Plan**

In the past two years, the Village of Lansing joined nine other municipalities, along with Tompkins County, the Ithaca-Tompkins County Transportation Council (ITCTC), and NYSDOT Region 3, in developing the Tompkins County Joint Safety Action Plan (JSAP). The plan, completed and released in July, outlines strategies and recommendations aimed at making local roads safer for everyone.

The JSAP takes a comprehensive approach to roadway safety, combining analysis of roadway design, traffic volumes, and crash data with strategies to influence user behavior. Its long-term vision is ambitious but vital: the elimination of traffic-related deaths and serious injuries across Tompkins County. By addressing safety concerns for all types of road users—including drivers, pedestrians, cyclists, and transit riders – the plan provides a roadmap for creating safer, more accessible transportation throughout the region.

### **Climate Smart Communities/Clean Energy Communities (CSC/CEC) Taskforce Report**

The Village has been Certified by New York State Department of Environmental Conservation as a “Climate Smart Community”

In June 2025, the Village of Lansing received official notification that it was one of three communities recently awarded the New York State Department of Environmental Conservation (NYS DEC) Bronze

level “Climate Smart Community” certification. In the July 10, 2025 announcement from the Office of the Governor, the recently certified communities were recognized for their *local actions to address the economic, social, and environmental challenges posed by climate change*. *The [state] interagency Climate Smart Communities (CSC) program provides guidance and technical support to local governments regarding climate action.*

The Village Climate Smart Community Taskforce recommended local actions, aligned with Village Plans and Policies and CSC goals, to the Village of Lansing Board of Trustees for approval. In collaboration with village staff and Cornell Cooperative Extension Tompkins County Climate Smart Communities/Clean Energy Communities Coordinators and in partnership with area municipalities and organizations, approved recommended actions were implemented and culminated in the recent certification of the Village as a Climate Smart Community.

Examples of accomplishments include, but are not limited to, participation in the county climate-resilient hazard mitigation planning, adopting a shade structures policy, compiling a fleet inventory, adopting a Natural Resources Inventory, providing staff training, participation in the Community Solar and Clean Heating and Cooling campaigns, incorporating sustainability elements in the comprehensive plan, serving as a food waste drop-spot which is managed by the county, tracking energy usage in village buildings, and participating in the preparation of a Government Operations and Greenhouse Gas (GHG) Inventory, and street light replacement with LED street lights.

### **State Grant**

The Village of Lansing’s Board of Trustees recently authorized the application for a 2025 Climate Smart Community Implementation grant for the *Uptown Road and Craft Road Sidewalk Connectivity and Expansion Project*, which was submitted at the end of July thanks to the coordinated efforts of: (1) Carolyn Greenwald (Deputy Mayor, Greenway Chair, and grant writer); (2) John Courtney (Department of Public Works Superintendent and CSC taskforce liaison who worked with the Village engineer on the proposed work plan and budget), Jodi Dake (Village Clerk for records management); (3) Climate Smart Community Taskforce Coordinator, Members, and Liaisons (Coordinator Mayor Ronny Hardaway, members Lynn Leopold, Patrick Gillespie, Kathleen Yen, Codes Enforcement Officer Mike Scott, and Cornell Cooperative Extension liaisons, Christopher Skawski and Jerry Sheng who provided expertise, technical assistance and information on funding sources).

## **TOMPKINS COUNTY LEGISLATURE**

2025 has been the Legislature’s most eventful year since 2020. Political turbulence and fiscal uncertainty in our national and state capitals, as well as increasing community and capital demands on limited county resources, require careful planning, conservative budgeting, and reevaluation of plans for a new county center of government. The Legislature needs to hear from you about all of these issues.

**First, the budget.**

Budgeting for 2026 is proving to be exceptionally challenging. Needs in the community continue to increase beyond our resources, and that trend promises to continue – and get worse – as we look ahead to 2027, when cuts to federal programs like Medicaid and SNAP go into effect. We must also anticipate cuts in federal and possibly state grant funding for county programs. (Our Department of Emergency Response reports that it may lose as much as 40% of its federal grant funding over the next couple of years.) At the same time, the inflation that plagues us all has also impacted the county’s operations, making even simple maintenance of effort significantly more costly.

We must also consider how to fund some “big ticket” additions to the county’s operating budget. Persistent malicious threats against county staff have made it clear that we need to provide county-wide security for our staff and at public meetings – at a projected annual cost of over \$600,000. Several of our departments are understaffed, and the cost of additional positions often exceeds \$100,000 in salaries and fringes. Our airport has requested county funds of almost \$2 million a year for the next three years, in an effort to become more competitive by reducing its costs per enplanement. And TCAT is requesting an additional \$500,000 per year from each of its underwriters (Tompkins County, the City of Ithaca, and Cornell University) to avoid incurring significant operating deficits in the coming years.

Meanwhile, the legislature has appropriated many millions of dollars of fund balance (over my strong and consistent opposition), rather than raise taxes to fund county spending over the past few years. While I understand that we want to keep tax increases to a minimum, I believe that overusing fund balance is neither the most responsible – nor the most transparent – approach to government budgeting. And, because we have substantially depleted our fund balance, most of our 2026 spending increases will have to be covered by property and sales tax revenues.

Bearing in mind that every \$500,000 or so represents a 1% increase in our tax levy, how much should we be spending, and on what? We need to hear from you, our constituents, as we make these choices. Please consider commenting at our Budget Forum (Tuesday, September 30 at 5:30 p.m. in the Legislature Chambers, 121 E. Court Street) and/or at the public hearing on the budget (Tuesday, October 28 at 5:30 in the Legislature Chambers). **Capital projects and the new Center of Government**

For years, the Tompkins County Legislature has considered and planned for a new Center of Government downtown. I have consistently supported this project because the NYS court system wants our County Clerk and DA staff out of the court building; county staff are currently scattered in several buildings, some of which we lease; and we have many employees working in very cramped conditions. However, years of detours and delays in the planning process have resulted in ever increasing costs, and we’re now looking at a project cost of \$50-60 million. At the same time, our Public Safety Building is in desperate need of updating or replacement, and we find ourselves having to build a homeless shelter at considerable cost. Given the challenging fiscal and economic climate, and the demands on our capital budget, I am inclined to consider alternatives to building a new Center of Government. Legislators have begun to explore alternatives to building in the downtown location, including a long-term lease on available properties. I will keep you posted on our progress, and, as always, I welcome your input on this issue.

This is the final year of my second term as your county legislator. It has been a privilege and a pleasure to represent you.
